## **Fridge Grant Program**

As a Public or First Nations school in BC, your school may be eligible to receive a grant to put towards the purchase of a refrigerator. Grants are awarded based on a school's need for adequate fridge space to promote healthy eating in your school.

The school may purchase a refrigerator from the supplier of their choice, and will be responsible for arranging its delivery and installation in the school. (*Fridges without freezers inside, and without ice makers and/or water dispensers on the door will ensure that you have as much room as possible for refrigeration purposes only.*)

Schools that are awarded a Fridge Grant will be required to submit a copy of the refrigerator's purchase receipt to the Fridge Grant Program c/o BC Agriculture in the Classroom Foundation. Receipts up to a value of \$1000 will be reimbursed to the school or the school district (not the PAC or an individual).

The school will assume responsibility for proper operation, maintenance, and repair of the fridge purchased.


